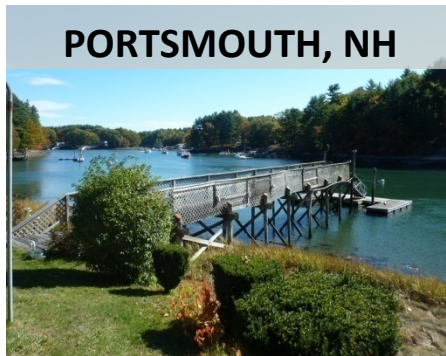

ACTON, MAINE

Trustee's Sale Live On-Site Auction
