TERMS AND CONDITIONS OF SALE

1. All bidders and others attending this auction agree that they have read and fully understand these terms and agree to be bound thereby. These terms are in addition to any verbally announced terms or other posted information, if any.
2. Dispute between bidders: If any dispute arises between two or more bidders, the Auctioneer may decide the same or may immediately put the lot up for sale again for resale to the highest bidder. The decision of the Auctioneer shall be final and absolute.
3. All property is sold "AS IS" and all property is sold Subject To Error.
4. Neither the Auctioneer nor the Consignor make any warranties or representations of the correctness of the brochure/catalogue or other descriptions of the physical condition, size, quality, rarity, importance, authenticity or provenance of the property being sold.
5. Prospective bidders should inspect the property before bidding to determine its condition, size and whether or not the property has been repaired or restored.
6. Responsibility: Buyer assumes complete responsibility for items at the time the Auctioneer says "SOLD".
